RESOLUTION (268-2017) APPOINT T. CAPOZELLA APIARY INSPECTOR

It was moved by Commissioner Sciarretti, seconded by Commissioner Metzger, to approve the following:

WHEREAS, Thomas Capozella has been determined by the Board of Commissioners to meet the minimum qualifications established for the position of Deputy Apiarist. Mr. Capozella has demonstrated the experience and knowledge of a Deputy Apiarist in Carroll County for two previous years and has met the statutory requirements of the Ohio Department of Agriculture.

RESOLUTION (269-2017) APPOINT COMMISSIONER JOE SCIARRETTI TO THE BOARD OF DIRECTORS OF THE TUSCARAWAS COUNTY HEALTHCARE CONSORTIUM

WHEREAS, Ohio law requires a regional council of governments to adopt bylaws determining the officers of the Council and method of selection thereof, creating a governing board to act on behalf of the council, appointing a fiscal officer and providing for the Council’s business.

WHEREAS, ARTICLE IV, SECTION 4.1 of the Bylaws of the Tuscarawas County Healthcare Consortium requires the establishment of a Board of Directors. The Board of Directors shall consist of five (5) members. The Tuscarawas County Commissioners shall appoint four (4) of these members and one (1) member shall be appointed by the remaining members by majority vote.

WHEREAS, ARTICLE IV, SECTION 4.2(1) of the Bylaws states the term of a director shall remain in office for two years or until the appointment of a successor is made.

This appointment shall fill the unexpired term of Commissioner Belle Everett.

It was moved by Commissioner Sciarretti, seconded by Commissioner Metzger, to approve the following Road & Use Maintenance Agreement with Chevron Appalachia LLC as approved by Joe Bachman, County Engineer and Robert Stephenson, Assistant County Prosecutor:

**MODEL ROADWAY USE AND MAINTENANCE AGREEMENT
FOR HORIZONTAL DRILLING PROJECTS AND INFRASTRUCTURE**

THIS AGREEMENT is entered into at New Philadelphia, Ohio, by and between TUSCARAWAS COUNTY, a political subdivision, whose mailing address is 832 Front Avenue, SW, New Philadelphia, OH 44663 (hereafter "County"), and RUSH TOWNSHIP, a political subdivision, whose mailing address is 4654 Rush Church Road SE, Uhrichsville, OH 44683 (hereafter "Township") (Township and County are collectively referred to as "Authority") and Chevron Appalachia, LLC, whose address is 800 Mountain View Drive, Smithfield, PA 15478 (Hereafter "Operator"), and shall be as follows:

RECITALS

WHEREAS, County and Township have control of the several county/township roads within Rush Township, in Tuscarawas County, Ohio and is required by law to keep such roads in good repair; and

WHEREAS, Operator is the operator of certain oil and gas leasehold, and intends to develop and operate the Jones Pad A and Jones Tank Pad, including the equipment, facilities, impoundments, and pipelines necessary for the operation of the Jones Pad A and Jones Tank Pad (hereafter collectively referred to as "oil and gas development site") located in Rush Township, in Tuscarawas County, Ohio; and

WHEREAS, Operator intends to commence use of 0.4 miles of CR 34 Weaver Run Road (Tuscarawas County) and 0.5 miles of TR 162 Kinsey Road (Rush Township) for the purpose of ingress to and egress from the Jones Pad A and Jones Tank Pad, for traffic necessary for the purpose of constructing sites and drilling horizontal oil and gas wells, and completion operations at the Jones Pad A and Jones Tank Pad (hereinafter referred to collectively as "Hauling Activity"); and

WHEREAS, Authority and Operator desire to enter into an agreement, providing for the repair and maintenance of said roads and bridges thereon as a result of such Hauling Activity; and

NOW THEREFORE, in consideration of the good faith performance by each party of the mutual covenants hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Operator agrees to the maintenance and repair of said roads and bridges, to their pre-Hauling Activity condition or as modified pursuant to Appendix A, thereon for any damages thereto, as a result of Hauling Activity related to such sites.

FURTHER, Operator shall also provide for the strengthening and upgrading of the roads and bridges if mutually agreed to be necessary, prior to or during any Hauling Activity. The areas and structures required to be strengthened and/or upgraded shall be determined by an engineer provided by the Operator with the approval of the County Engineer to be provided within thirty (30) days of a written request submitted by the Operator. Operator's engineer shall provide a written report to the County and/or Township detailing the condition of the roads and appurtenances covered under this Agreement along with any recommendations, if necessary.

BOTH PARTIES FURTHER AGREE to the following additional terms and conditions:

1. The portion of 0.4 miles of CR 34 Weaver Run Road (Tuscarawas County), to be utilized by Operator hereunder, is that exclusive portion beginning at the intersection with TR 162 Kinsey Road and ending at the site entrance for Jones Tank Pad (the "Haul Route"). It is understood and agreed that the Operator shall not utilize any of the remainder of CR 34 Weavers Run Rd for any of its Hauling Activities hereunder.

The portion of 0.5 miles of TR 162 Kinsey Road (Rush Township), to be utilized by Operator hereunder, is that exclusive portion beginning at the intersection with SR 800 and ending at the intersection with CR 34 Weaver Run Road (the "Haul Route").

2. Pre-Activity Repairs to 0.4 miles of CR 34 Weaver Run Road (Tuscarawas County) and 0.5 miles of TR 162 Kinsey Road (Rush Township) to be performed by County: Operator and County mutually agree that Repair in accordance with County's design requirements are necessary to 0.4 miles of CR 34 Weaver Run Road (Tuscarawas County) and 0.5 miles of TR 162 Kinsey Road (Rush Township) as further described in the attached Exhibit A – Pre-Activity Repairs completed by Tuscarawas County. County shall perform the Repairs specified herein using a contractor of its choosing so as to complete said Repair on or before May 1, 2017. County shall obtain any and all necessary rights of way and permits for said Repair. Operator shall provide funding (hereafter, "Operator's Pre-Activity Repair Obligation") to the County for 100 % of the total reasonable costs incurred by County for said Repairs but in no event shall Operator's Pre-Activity Repair Obligation exceed a total amount of \$96,500. During its performance of the Pre-Activity Repair, County shall invoice Operator on a bi-weekly basis for the Operator's Pre-Activity Repair Obligation. Operator shall pay the County within 30 days of receiving an invoice. The County has complete control, supervision and direction over its equipment and personnel, and over the manner and method of performance of the Repair. At all times, during the construction of the Repairs and after their completion, the Repairs to County-owned roads will be owned and maintained by County and Repairs to Township-owned roads will be owned by Township.}

Pre-Activity Repairs to 0.4 miles of CR 34 Weaver Run Road (Tuscarawas County) and 0.5 miles of TR 162 Kinsey Road (Rush Township) to be performed by Operator: Operator and County mutually agree that Repair in accordance with County's design requirements are necessary to 0.4 miles of CR 34 Weaver Run Road (Tuscarawas County) and 0.5 miles of TR 162 Kinsey Road (Rush Township) as further described in the attached Exhibit B – Scope of Work Letter to be completed by Operator. Operator shall obtain any and all necessary rights of way and permits for said Repair. At all times, during the construction of the Repairs and after their completion, the Repairs to County-owned roads will be owned and maintained by County and Repairs to Township-owned roads will be owned by Township.

3. Operator shall reimburse Authority for the Authority's reasonable and actual costs of conducting maintenance made necessary as a result of Operator's Hauling Activity on the Haul Route or repairing damages caused by Operator's Hauling Activity, at Operator's sole expense, throughout the term of this Agreement, to a level consistent with the condition of the Haul Route at the commencement of the Operator's Hauling Activity hereunder, as determined by the Operator's engineer in its pre-Hauling report required in Appendix A. The maintenance of the Haul Route includes the use of a commercially recognized dust palliative to control the airborne dust created and/or contributed to by the Operator or the Operator's contractors and or agents.
4. Either the Operator, the County or the Township may terminate this Agreement with just cause following at least thirty (30) days written notice to the other of its intent to terminate. As soon as possible after receipt of such notice, the County, the Township and the Operator shall inspect the Haul Routes. Following final inspection, the parties shall meet, and all restoration resulting from Operator's Hauling Activity shall be identified and thereafter completed by the Operator, at Operator's sole expense. Following completion of all restoration work, this Agreement shall be terminated and of no further force or effect.
5. All motor vehicles to be utilized by Operator hereunder, whether owned by Operator or Operator's employees, agents, and contractors, shall comply with all legal size, load and weight limits in accordance with State Law. Any and all requirements of Ohio's Frost Law (ORC Ann. 5577.07) or any City or other local requirements related to the Frost Law, shall not apply to Operator's Hauling on the Haul Route during the term of this Agreement.
6. Operator shall furnish the County and the Township with a written Letter of Authority, setting forth all necessary contact information, including a twenty-four (24) hour emergency contact number, for the authorized local representative of the Operator, and such information shall be maintained and kept current at all times concerned hereunder.
7. If the County and/or the Township determines that any additional traffic signage is needed, or desired, as a result of this Agreement and in the interests of safety, then Operator shall provide for such signage at Operator's sole expense. In the event that any other safety concerns should arise during the course of this Agreement, Operator, the County and the Township agree that they will mutually discuss such concerns and reach a resolution satisfactory to all concerned.
8. Operator shall protect, save, indemnify, and hold the County and the Township, its officials and employees harmless from any liability, claims, damages, penalties, charges, or costs which may arise or be claimed as a result of any violations of any laws or ordinances, or any loss, damage or expense to the Haul Route proximately caused by Operator's Hauling Activity during the term of this Agreement.
9. Operator assumes all liability for Operator's employees, subcontractors and or agents.
10. This Agreement shall be binding upon Operator and the County and the Township, and their respective successors and assigns.
11. In any event that any clause, provision or remedy in this Agreement shall, for any reason, be deemed invalid or unenforceable, the remaining clauses and provisions shall not be affected, impaired or invalidated and shall remain in full force and effect.

12. Agreement shall be governed by the laws of the State of Ohio.

Appendix A

Operator shall:

- 1) Videotape the Haul Route prior to Hauling Activity.
- 2) Provide Authority with an engineering report detailing pavement thickness and composition, base thickness and composition, and subgrade composition, as and if reasonably determinable of the Haul Route prior to. Engineering report to also provide an analysis of conditions along with a recommendation, if mutually agreed to be necessary, for upgrading roadway to handle anticipated Hauling Activity.
- 3) Upgrade CR/TR in accordance with the attached Scope of Work Letter, dated 03/13/2017.

Authority shall:

- 1) Provide for minor maintenance of the road during the Hauling Activity for damages not caused by said Hauling Activity. For any work that is to be reimbursed by the Operator to the Authority, Authority agrees to give 48-hour prior notice to the Operator (or agrees to notify Operator when maintenance is needed).
- 2) Provide for maintenance of the roadway and bridges for damages not caused by the Hauling Activity at the Authority's cost and expense, including snow/ice control, mowing, etc.
- 3) Provide the Operator with a list of all current operators with a RUMA on any portion of the Haul Route.
- 4) Notify the Operator within 48 hours of any new operator executing a RUMA with another operator for any portion of the Haul Route.

To whom it may concern:

The purpose of this letter is to state the roadway improvement scope of work to be performed by Chevron Appalachia, LLC on TR-162 (Kinsey Road) and CR 34 (Weavers Run Road).

TR-162 (Kinsey Road) is located in Rush Township, Tuscarawas County, Ohio. The scope of work is to include 0.5 miles from the intersection with SR 800 (Smyrna/Freeport-Tippecanoe Road) to the intersection with CR 34 (Weavers Run Road). The existing roadway is approximately 16' in width. It is proposed to perform the following work:

- Widening of the roadway from 16' to 18' wide by milling 4' wide by 11" deep on both sides of the roadway. Fill the mill cut with 7" of #1 AASHTO or equivalent and compact. Choke the #1 AASHTO with 2" of 2A stone or equivalent. Fill the remaining 4" with 302 Asphalt Concrete Base. Seal all the edges of the widening.
- Perform a scratch coat with 442, followed by a 5.25" Overlay. Place 3" of 301 Asphalt Concrete Base, followed by 2.25" of 12.5mm 442 Superpave Asphalt Concrete.
- After full width pavement is installed perform full length shoulder back up with 3A stone or equivalent and compact.

CR 34 (Weavers Run Road) is located in Tuscarawas County, Ohio. The scope of work is to include 0.35 miles from the intersection with TR-162 (Kinsey Road) to the intersection with the Jones Pad A Site Entrance "B". The existing roadway is approximately 19' in width. It is proposed to perform the following work:

- Perform a 2" overlay of 12.5mm 442 Superpave Asphalt Concrete per engineering judgement.
- Perform full length shoulder backup with 3A stone or equivalent and compact after full width pavement is installed.

The Jones Pad A Site will have two (2) site driveways, which have already been permitted.

All work is to be performed and constructed to current ODOT standards and specifications.

Discussion: Nate Kamban (Transitional Assistant Superintendent, Board of Developmental Disabilities BDD), Kellie Brown (Interim Superintendent BDD), Christine Sapp (Community Connection Specialist BDD) and Laura Nepesa a young woman that receives services from the Board were present for the proclamation of Developmental Disabilities Awareness Month. Mr. Kamban stated that he knows Ms. Nepesa from elementary school and church. Ms. Nepesa is a real “go getter” and is community employed. What has resonated with him is when she said she would like a career, not just a job. Careers help us fulfill our dreams. Ms. Nepesa’s goal is to work with children, focusing on children with disabilities in a day care center. Mr. Kamban wanted the Board of Commissioners to meet Ms. Nepesa and celebrate Development Disabilities Awareness Month. Other activities include staff vs. Special Olympics basketball game, speakers to speak on trauma care and how it affects disabilities, a talent show (which Ms. Nepesa is participating in) and a social event utilizing communication devices instead of speech. Kim Byrd, another client is featured in a statewide publication. The Commissioners appreciate all the work of the BDD does which touches so many lives. Commissioner Sciarretti pointed out they are also good partners and explained an office had a need for a file cabinet and BDD provided one for them.
