

COLLEGE STUDENT SUMMER JOB DESCRIPTION

- Must be a high school graduate planning to be in school in the fall
- Must have a valid Ohio driver's license
- Must be able to perform physical labor. Duties may include painting, flagging traffic, patching asphalt roads, sign repair/replacement, mowing and any other duties associated with the department.
- Employment is for a maximum of two summers and a maximum of fourteen weeks per summer. Students who perform satisfactorily in the first summer will automatically be invited back for the second summer. Start date and end date for employment is adjustable depending on the student's schedule.
- Safety equipment is supplied by the County. The student will need to have leather work boots (no tennis shoes) and comply with our safety rules (no shorts, no dangling jewelry, etc.)
- 2018 pay rate is \$9.00 per hour for first year students and \$10.00 per hour for second year students. Holidays are paid if student is on payroll at the time. No social security is deducted from the pay; however, a deduction for Public Employees Retirement System (PERS) is taken. This PERS deduction can be returned to the student by application to PERS three (3) or more months after final work date (with a minimal penalty for withdrawal). In addition, a Medicare deduction is taken.
- Normal summertime work week is 4 ten hour days - Monday thru Thursday from 6:30 am to 4:30 pm.
- Please be aware that you will be subject to random and/or scheduled drug and alcohol testing as a condition of summer employment.
